JOHN EDWARD BARRINGTON, formerly known as **JOHN STUART JAKOWS** is reported to be collecting down payments, construction draws, investments and deposits from prospective buyers on homes being constructed in Orange and Osceola County, Florida. There are a number of claims filed in Orange and Osceola County Circuit Civil Court that John Barrington has collected these deposits and has not performed in accordance with his written agreements with these prospective borrowers. It is reported there are currently more than \$2 million in default judgment of record filed against Barrington and his various corporations.

Of more immediate concern is that John Edward Barrington, formerly known as John Stuart Jakows is a convicted felon with more than 72 convictions dating from 1990 through 2002 that have resulted in Barrington serving four separate prison terms dating between April, 1991 through July 1995; September 1996 through August 1997; October 1997 through March 2000; and October, 2001 through July 2002. **Barrington is currently under supervised probation until July, 2009.**

Barrington has been charged with and convicted of a multitude of felony crimes including Grand Theft, Forgery or Uttering a Forged Instrument; Organized Fraud; Gross Fraud or Cheat; Auto Theft; Fraud by Check and Negotiating a Mortgage Loan without a License.

Barrington is reportedly operating the following active corporations: **BARRINGTON HOMES, INC., (a Florida corporation); RIVERSIDE ESTATES LTD. CO. d/b/a RIVERSIDE ESTATES, LLC; STEALTH HOMES, INC.; MEADOW WOODS ESTATES, LTD.; Highbrooke, LLC; MEADOW WOODS ESTATES CONDOMINIUM ASSOCIATION, INC.; AMERICAN SECURITY FIRST, INC.; BARRINGTON REALTY & ASSOCIATES, INC.; and BARRINGTON ROOFING, INC.** Barrington has also operated under these other corporate names in the past: COMMUNITY CARE CENTER, INC. and INVESTOR FINANCIAL SERVICES, INC.
